ORDINANCE NO. _____
(June 8, 2019 Runoff Election Canvass)

AN ORDINANCE OF THE CITY OF ANNA, TEXAS CANVASSING THE RETURNS OF A RUNOFF ELECTION FOR ONE CITY COUNCIL MEMBER, FOR A THREE-YEAR TERM EXPIRING MAY 2022.

WHEREAS, an election was held in the City of Anna, Texas on June 8, 2019 for electing one city council member, for a three-year term; and

WHEREAS, the City Council of the City of Anna (“Council”) has reviewed and investigated all matters pertaining to this election and returns thereof; and

WHEREAS, the Council hereby canvasses the returns of this election, at which there was submitted to all resident, qualified electors of the City for their action thereupon, the election for one city council member, for a three-year term; and

WHEREAS, the Council has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to this Council by the judges, officials and clerks holding and conducting the election, the poll lists and the official elections returns showing separately the votes cast in the election; and

WHEREAS, from the returns, this Council hereby finds that the following votes were cast in the election by voters who were resident, qualified electors of the City; and

WHEREAS, each of the candidates in said election received the following votes;

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF ANNA THAT:

SECTION 1. The Council officially finds, determines, and declares that the election was dully and properly ordered, that proper legal notice of such election was duly given in the English language and the Spanish language, that proper election officers were duly appointed prior to the election, that the election was duly and legally held, that all resident, qualified electors of the City were permitted to vote at the election, and due returns of the results of the election had been made and delivered, and that the City of Anna has duly canvassed such

returns, all in accordance with the laws of the State of Texas and of the United States of America and the Ordinance calling the election.

SECTION 2. The following person is therefore elected as Council Member of the City for a term of three (3) years:
