This includes alterations/modifications to the following: System Risers, Less Than 10 Sprinkler Heads, or Less Than 10 Horn/Strobe Notification Devices. Contractors conducting general maintenance or similar services shall install a white service tag indicating the location (i.e. Suite #) and scope of work (i.e. "Added horn/strobe").**
