## Building Registration Permit Fees

Contractor's registration.....\$100.00

***Renewal required annually. No construction permits will be given without contractor's registration.***

## Residential Construction Permit Fees

Residential Building Application..... \$60.00

Residential Certificate of Occupancy..... \$50

➤ Master Permit Plan Review

- *Single Family, Duplex, Townhouse, Condominium, Multifamily.....* \$200 per elevation/ floor plan

➤ Plan Review

- *Single Family, Duplex, Townhouse, Condominium, Multi-Family, Manufactured Home.....* \$300 per unit
  - *Additions, Alterations, Repairs, Remodels.....* \$100 per room
  - *Mechanical Permit.....* \$125
  - *Electrical Permit.....* \$125
  - *Plumbing Permit.....* \$125

➤ Building Permit

- *Single Family, Duplex, Townhouse, Condominium.....* \$2,400 per unit
- *Multi-family.....* \$1,100 per unit
- *Additions, Alterations, Repairs, Remodels.....* \$200 plus \$.70 of total enclosed area\*

*\*Minimum charge of \$785*

## Commercial Construction Permit Fees

Commercial Building Application..... \$60

Building Permit..... \$.50 per sq. ft. of total enclosed area

➤ Plan Review..... \$.20 sq. ft.

- *Additions, Alterations, Repairs, Remodels.....* \$.70 per sq. ft. of total enclosed area
- *Mechanical Permit.....* \$125
- *Electrical Permit.....* \$125
- *Plumbing Permit.....* \$125

Shell Commercial Permit..... \$.35 per sq. ft. of total enclosed area for plan review and building permit

\*\* Per the International Residential Code, one-story, DETACHED accessory structures (residential properties) under 200 square feet, that do not contain electrical, plumbing, or mechanical are exempt from obtaining a permit but must comply with setbacks.
