*Minor modifications to fire protection equipment do not require permit submittal or fee payment, however, a scope of work letter shall be submitted. This includes alterations/modifications to the following: System Risers, Less Than 10 Sprinkler Heads, or Less Than 10 Horn/Strobe Notification Devices. Contractors conducting general maintenance or similar services shall install a white service tag indicating the location (i.e. Suite #) and scope of work (i.e. "Added horn/strobe").

- CONSTRUCTION PERMITS EXPIRE **180 DAYS** FROM THE DATE OF ISSUANCE.
- OPERATIONAL PERMITS REMAIN IN EFFECT FOR THE TIME PERIOD SPECIFIED IN THE PERMIT.
